Brief outline of the course: Basic features and characteristics of public administration (history, political background). Language and terminology of public administration. Business communication (telephone communication, past tense, starting and ending a conversation). Making suggestions and recommendations (modal verbs, compounds). Presentations (formal academic presentations in English, structure of presentations). Case studies. Grammar: irregular plural of nouns, irregular verbs, modal verbs, passive voice. Language functions necessary for professional communication: defining, classifying, cause/result, expressing opinion, similarity/difference etc.
