<b>Conditions for course completion:</b> The prerequisite for the award of a grade in the course is active participation in class and obtaining a sufficient number of points for the interim assessment (activity in meetings, presentation/analysis) and the final assessment (final semester-long written examination). The final grade for the course will be calculated based on the sum of the scores of the midterm and final evaluations. The student is allowed a maximum of two absences. In the case of more than two absences, the student does not meet the requirements for successful completion of the course. In the event of any attendance problems, the student shall, on his/her own initiative, contact the instructor with information about his/her absence. The course is taught primarily in a face-to-face format, supplemented by distance learning tools. Opportunity to earn points towards the grade for activity during class. Final assessment: Written examination (max. 25 pts.; min. 13 pts.). Continuous assessment: Once during the semester (as per the Schedule), the student will prepare a 20-minute presentation on a selected MV actor (max. 10 pts.) and will also be active in analyzing contemporary developments on a level topic (5 pts.). In the presentation, the student will focus on situating the selected actor in the broader context of international relations and foreign policy, its anchoring, categorization, typology, history, and potential contribution or threat to the stability of the international system. Students are required to write the topic of their presentation on the "Schedule of Seminars" spreadsheet no later than 7 days after the introductory class. Passing the midterm evaluation is a condition for admission to the course examination. In the event that a student does not attend the seminar at which he/she is to present the selected topic, he/she is obliged to notify the course lecturers and to arrange a substitute with the students in the study group whose presentation follows (see Schedule). Opportunity to earn points towards the grade for activity during class and bonus assignments. Student is allowed a maximum of 2 absences. Presentations will also take into account the overall presentation and the form of the presentation, which should approximate the lecture output in form and content.	
<b>Learning outcomes:</b> The course deals with the different actors in international relations, their legal and political status. It provides a detailed characterization of both state and non-state actors in international	

relations. Students will learn to identify different types of actors, characterize the roles of actors in international relations, and analyze the interactions between actors. Provides and discusses specific examples based on an established typology. It also emphasizes the identification and explanation of the concept of lobbying in international relations as a way of negotiation between interest groups. In the course of the course, the student will learn to better navigate current international relations and be able to identify the different actors in them, their intentions, abilities, potential, position, role and influence on other actors.

Objectives:

To identify and interpret the intentions and strategies of actors in international relations and to anticipate possible scenarios.
