Mastering the conditions of the continuous and final evaluation in an overall expression of at least 52 points. A total of 100 points can be obtained per semester with exam and during the semester, the minimum number of points for passing the subject is 52. Final assessment scale: 100 - 91 A; 90 - 81 B; 80 - 71 C; 70 - 61 D; 60 -52 E; 51 - 0 FX.	
<b>Learning outcomes:</b> The aim of the subject is to increase students' financial literacy. The subject is focused on banking and insurance as part of the national economy, it defines the legislative framework of these industries. Students will have the opportunity to familiarize themselves with the organization of the banking system in Slovakia, with the position of the National Bank of Slovakia, the Central European Bank, as well as other banks in the market system. Using specific examples, they will learn to use payment instruments, they will have the opportunity to familiarize themselves with the basic steps and documentation for concluding credit agreements. The aim of the course is also to make students understand how the single insurance market works, to learn how to navigate insurance products and industries.

1. Financial system: The role of the financial system, financial markets and financial instruments, participants on financial markets, regulation of financial markets.
2. Management of monetary circulation and issuance of banknotes and coins. Monetary policy.
3. Historical development of banks. Organization of the banking system in Slovakia. Position and functions of the central bank. NBS in the Eurosystem.
4. The essence of the existence of the CB and its function of the ECB - its bodies and tasks. The Eurosystem and its tasks. National Bank of Slovakia - its goals, tasks, position.
5. Division and functions of commercial banks in Slovakia. The division of commercial banks, their position and tasks. Business principles of commercial banks. Structure of products of commercial banks. Cashless payment system and its instruments.
6. Banking risks and their management. Banking operations.
7. Electronic banking and private banking.
8. Insurance as part of the national economy. Insurance market. Legislative foundations of the insurance industry. Development of the insurance industry in Slovakia.
9. Slovak insurance industry and the EU. Basic categories of insurance. Insurance participants. Insurance functions.
10. New trends in the Slovak insurance industry. Characteristics of life and non-life insurance. Contractual and statutory insurance. Liability insurance.
11. Collateral and its meaning.
12. Bancassurance - causes and reasons for its creation. Specific bancassurance products.
13. Final summary of the discussed issues.
