By passing the course, the student acquires the skill to apply an analytical, synthetic, and comparative approach to the perception of the essential elements of the delimitation of administrative and criminal offences through the related case law of administrative courts in order to acquire advanced knowledge of the legal discipline related to criminal law (administrative law) in the related problematic (administrative law of sanctions). Primarily, the student will become familiar with the scientific examination of the legal regulation and decision-making practice concerning administrative sentencing actions with potential subsequent impact on criminal proceedings in the event of a reclassification of an act to a criminal offence and vice versa. The teaching includes identification, examination of the causes and legal solutions to the legal-applicational deficiencies in the application of the right of defence in proceedings concerning an administrative offence, with particular emphasis on block proceedings as a type of summary offence proceedings, followed by a scientific examination of the legal position of a person injured by an administrative offence and a person injured by a criminal offence, with comparative conclusions leading to de lege ferenda proposals, the gradual establishment of a scientific examination of the criminal and administrative law aspects of the right of a witness under the age of 18 to refuse to testify, and finally, the knowledge and scientific approach to legal reasoning in the application of criminal law analogy in administrative offence proceedings under the Code on Administrative Trial Proceedings in the context of the administrative courts case-law.

Scientific examination of the nature and impact of relevant case law in the administrative justice system concerning the connections between administrative and criminal offences as well as the interrelationship of the proceedings thereon in the light of substantive and procedural law.

Clarification of the analytical, synthetic, and comparative approach to the perception of the essential connections regarding the delimitation of administrative and criminal offences through the related administrative courts case law.

A scientific examination of the law and decision-making practice of judicial proceedings on administrative sentencing actions with potential subsequent impact on criminal proceedings in the eventual reclassification of an act to a criminal offence and vice versa.

Identification, examination of the causes, and legal solutions to the legal-applicational deficiencies in the application of the right of defence in administrative offence proceedings, with particular emphasis on block proceedings as a type of summary administrative offence proceedings.

Scientific examination of the legal status of a person injured by an administrative offence and a person injured by a criminal offence with comparative conclusions leading to de lege ferenda proposals.

A scientific examination of the criminal and administrative law aspects of the right of a witness under the age of 18 to refuse to give evidence.

Understanding and scientific approach to the legal argumentation in the application of criminal law analogy in the proceedings on administrative offences under the Code of Administrative Trials Proceedings in the context of administrative courts' case law.

To this day, the constitutional law concept of the so-called First Czechoslovak Republic is considered to be the basis for the constitutional development of Czechoslovakia and later Slovakia as an independent state. Some of its elements are also applied today in the constitutional law of the Slovak Republic. By passing the compulsory elective course, PhD students get the opportunity to understand the link between the past and the present. First of all, they will understand the very difficult and complex creation process of the new state, which was shaped primarily by the determination of the new state borders. This issue still sometimes provokes international disputes, especially with radical politicians across our southern border. In 1918, the foundations of the Czechoslovak, and later Slovak, constitutional system were laid. The development of the individual constitutions in our territory does not, of course, end with the establishment of the wartime Slovak state; it continues to this day, a dynamic process that is gradually experiencing change. Awareness of its foundations will enable the PhD graduate to formulate de lege ferenda proposals that he will be able to apply in his future legal practice.
