Ongoing evaluation (max. 70 points) consists of: <ol style="list-style-type: none"> <li>1. attendance at classes (teaching as well as passing the individual parts of the assessment will take place according to the current situation, namely face-to-face or remotely (LMS, MS Teams) - to be admitted to the exam, attendance at min. 80% of the entire teaching, while part of the teaching can take place in the form of discussions, excursions, etc., which are conditional on the student's participation. Part of the teaching replaces the performance of the student's voluntary activity;</li> <li>2. presentation of research in the field of volunteering in social work (10 points) at a pre-agreed date in PowerPoint or Prezi form (10 minutes) in the established structure. Specific research must be submitted in pdf form via the LMS e-learning system by the deadline. In case of failure to submit it or delay in submitting it, the student loses the opportunity to get points for submitting the assignment (3 points);</li> <li>3. continuous test - at a pre-agreed date, max. 10 points, with which the student is verified as identifying and remembering basic concepts related to the field of volunteering in social work, being able to identify and describe types and forms of volunteering, and interpreting the Act on Volunteering;</li> <li>4. performance of the student's voluntary activity in the specified range in an institution that cooperates with volunteers in the social field and by presenting a confirmation of its completion (25 points). The scope of voluntary activity replaces part of the teaching;</li> <li>5. video presentation of the student's volunteer activity (approx. 10 minutes) (25 points) at a pre-agreed date.</li> </ol>	

A total score of 37 points from the ongoing evaluation is required for admission to the exam. In case of failure to meet the conditions (failure to obtain the required 37 points in the ongoing evaluation, or failure to meet the participation condition, failure to meet the condition of completion of the student's volunteer activity or failure to present it in the form of a video), the student will not be classified in the subject (rating X).

Final evaluation (max. 30 points):

During the written examination, a maximum of 30 points can be obtained, of which the minimum number of points for awarding the assessment is 16. In the event that the student does not obtain this minimum set number of points (16 points) from the examination, despite a sufficient number of points from the interim assessment, it will be given an rating FX.

To pass the exam in advance (the last week of the semester at the time of the lecture), a score of min. 56 points from the interim assessment.

The written exam is to check the student's ability to interpret, apply and explain the acquired knowledge in the field of volunteering in the practice of social work.

The final evaluation (0-100 points) is the sum of the ongoing assessment and the completed written exam.
